S. 2nd Year classes that they must come to the College **Office Counter no. 03** along with the Admission Forms & H. S. 1st year Mark-sheets for necessary approval of the same as per the following schedule positively:

After that, they will have to go through the College Admission Portal once again and click the fees payment button so as to complete their admission process by paying the requisite amount of fees latest by 12/07/2025.

Further, in pursuance of the Govt. of Assam O. M. Vide. No. E-490303/2024/83, dtd. 04-06-2025, it is also informed to those Students who got admission under Fee Waiver Scheme into 1st Year for the year 2024-25 & whose parental annual income is below Rs. 4 Lakh are only eligible to take admission under Fee Waiver Scheme.

Such Fee Waiver category of Students before visiting the online mode of Admission Payment, must attend the College from 08-07-2025 to 09-07-2025 at 11:30 am to 02:30 pm in Counter No – 05 with the following documents for Submission / Verification / Uploading their data in the system. Failing which no further request will be entertained.

1. Downloaded copy of Admission form.
2. Income Certificate or Ration Card issued by the competent authority.
3. Declaration / Undertaking from the Student.
4. Photograph of the sapling, planted previously in H.S.1st year during 2024-25.
5. Copy of H. S. 1st Year Admit Card, Marks-Sheets.
6. Copy of H. S. 1st Year College Fee Card.
7. Copy of PRC / Voter ID / NRC / Aadhar Card / BPL Card / Passport of Self or Parent / Birth Certificate relating to Domicile of Assam as per the list of Govt. of Assam.
