

ADMISSION TO H.S. FIRST YEAR FOR THE SESSION 24-25

In suppression of the earlier notification dated 06.05.24, it is hereby notified that

1. All students selected for admission in Gurucharan College through DARPAN for admission into H.S. first year (Arts, Science, Commerce) for the Academic Session 2024-2025 **should keep their UDISE no. and PEN with them which will be required during distribution of Identity Card and Fee Card.**

2. All students who have been selected for admission in Gurucharan College and have accepted admission in Gurucharan College, are to come for offline verification with **all their original documents including acknowledgement receipt of Darpan**, along with photocopies as per the following schedule

3. Students of Boards other than SEBA are to get their online marksheets attested by the Head of their respective institutions.

4. Before admission, each and every student will have to generate their UNIQUE ID from the website of the director of Higher Education, Assam (<http://dheonlineadmission.amtron.in/sp/index>). Link is also given in the college website.

5. In pursuance of the Govt. of Assam O.M. vide No.AHE.354/2021/8 dtd.06-09-2021, students who are seeking admission under Fee Waiver Scheme must note down the following:

i) Fee waiver Scheme is applicable only for those students whose parental annual income is below Rs. 2 lakhs

ii) If either of the parents (mother or father) is working as an employee in the State Govt. /Central Govt./Semi Govt./State or Central Govt. undertaking, then such students will not be eligible to apply under the Fee Waiver Scheme.

iii) An Income certificate having the current validity of one year (for eg. December 23 -December 2024) by the Local Revenue Circle officer shall only be considered as proof of income.

iv) A Declaration/ Undertaking from the Students that neither of the parents (father or mother) employee in the State Govt. /Central Govt./Semi Govt./State or Central Govt. undertaking shall be required at the time of Offline verification. The Form is attached herewith.

v) The students have to plant a sapling at his/her college or at his/her home and shall submit a photograph of the same during offline verification. Further, the students have to nurture the sapling and have to submit the photograph of the same tree that was planted during admission to H.S. first year 2024-25 during admission to second year

vi) For availing the Fee Waiver Scheme, to prove that a student has a domicile of Assam, he/she must submit photocopy of any of the following documents during Offline Verification to prove domicile as per the list of the Govt. of Assam :

PRC/ Voter ID of Self or Parent/NRC of Self or Parent/Adhar Card of Self or parent/BPL CARD/Birth Certificate/Passport of Self or Parent.

vii) List of documents for Fee waiver Scheme:

- a) Income certificate (point no.5 .iii)
- b) Declaration/Undertaking by the student (point no.5. iv)
- c) Photograph of sapling planted (point no. 5.v)
- d) Copy of Admit card/Mark Sheet of HSLC
- e) Copy of PRC/ Voter ID of Self or Parent/NRC of Self or Parent/Adhar Card of Self or parent/BPL CARD/Birth Certificate/Passport of Self or Parent. (point no.5. vi)
