ORDER

Whereas, heavy rains have affected the District during the last 24 hours where some roads are blocked due to water logging/ flooding are being reported in various parts of the City/District. Under such circumstances, the movement of school children's/ students may not be safe and is required to be restricted.

Therefore, in exercise of the power vested in me under Section 34(M) of Disaster Management Act, 2005 it has been decided that all the Government educational institutions/ Private educational institutions/ Colleges/University(s)/ ITIs/Training Centre/ AWCs shall remain closed on **05th August 2025** in Cachar District. The Heads of the institutions shall ensure strict compliance of the above said order.

However, pre-scheduled examinations shall not be impacted and will be conducted as per the existing schedule.
